This is particularly important as our nation struggles with an obesity crisis, families struggle with work/life balance and individuals search for personal fulfillment.

Our YMCA believes in giving back and supporting our neighbors. We have been listening and responding to our community's most critical needs for more than 115 years. Y programs, such as ESOL - English for Speakers of Other Languages (42 adults), Armed Services YMCA, and Y Community - providing family time activities at the Y for the homeless (314 individuals) are examples of how we deliver training, resources and support that empower our neighbors to effect change, bridge gaps and overcome obstacles.

In 2015, 1,778 volunteers served the YMCA approximately 54,750 hours at a value of \$1,587,203.
