Registration Fee:	All registrations require a \$50 non-refundable registration fee per family, per school year.
Program Shutdown:	Programs may shut down for 1-3 days at the end of the school year and/or the end of summer for site preparation and staff training. Notice will be provided of the specific dates at least 6 weeks prior to the closures. Subject to change if the school calendar changes
Withdrawals & Vacation:	A fifteen-day written notice is required for all withdrawals, vacation requests or changes in care to be eligible for credit or refund if eligible. Please request a Child Care Change Form to provide this notice.
Non-Student and Break Days:	Additional "mini" registrations are required for non-student days and school breaks for all participants. Registration for all non-student and break days close the Wednesday prior to care.
Holidays:	Care is available on Martin Luther King Jr. Day and Veterans Day. Participation on these days may be provided at an alternate site pending enrollment numbers. Care is NOT available on New Year's Day, President's Day, Memorial Day, 4th of July, Labor Day, Thanksgiving, the day after Thanksgiving and Christmas Day. Programs may close early on Christmas Eve and New Year's Eve.
Part-Time Care:	Part-Time care is available to families currently enrolled in PT care for 2017-18. Any available spaces will be offered to new enrollments in August 2018. Part-Time Fee Options Sheet available upon request.
Occasional Care:	Occasional Care is a service we provide to families whose children are currently enrolled in the YMCA School Age Care Program. It is child care on an EMERGENCY or IRREGULAR BASIS during a time outside of the regular enrollment. Occasional Care is not available at all sites and times. Payment must be made in advance at the branch. Participants must receive prior approval of program staff to confirm space is available.

Automatic Draft Discount: Subtract \$10/month if you choose to use monthly bank or credit card draft.

Multiple Children Discount: Families with more than one child will be given a 10% discount on the lesser rate. 10% discount is applied after any \$10 bank draft discount is calculated.

PAYMENT METHOD OPTIONS

Credit Card or Bank Draft:	Automatic draft is our preferred payment plan. Bank draft allows parents to pay half of the fee on the 25th of the month prior to care and the remainder of the fee on the 10th of the month. Those participants who chose automatic draft receive a \$10/mo. deduction in the child care fee, as it is more economical for our billing department. There is a separate form for Bank Draft and Credit Card Authorization. Child Care Automatic Drafts begin the 2nd month of enrollment due to the length of time needed to process the draft. The first month of enrollment is paid by cash, check or credit card.
Standard Pay:	Child Care payments paid by check or cash are due on the 25th of the month prior to the month of care. If payment is not received, your child will not be eligible to attend on the 1st day of the month. A \$30 late fee will be applied to all late payments.
DSHS and Government Subsidy:	The YMCA accepts DSHS subsidies. An Awards letter covering the current period is required at the time of registration. DSHS provider numbers are available at the Branch and School Age Care Locations. Co-pays are subject to the same payment deadlines for care. Children who qualify for DSHS subsidy can receive a Youth membership for \$17/year.
Financial Aid:	Financial aid is available to those who qualify. Assistance is granted on a first come first serve basis. Assistance will be granted for a maximum of the length of the program. You can reapply to receive continued assistance.
