**MARYSVILLE & LAKE STEVENS SCHOOL DISTRICTS**

All School-Age Care plans include a YMCA of Snohomish County youth facility membership for the duration of the current year's enrollment.

<b>School Year Plan</b>		Monthly Care Option 5 days per week
For participation on non-school days & breaks, but NOT summer (first day – last day of school) Must register for this option by November 30

<b>Year Round Plan</b>		Monthly Care Option 5 days per week
For participation 12 months of the year (first day – last day of school & select summer camps) Must register for this option by October 31 Not available for those with DSHS or other government subsidy		
<b>Before School Care</b> <ul style="list-style-type: none"> <li>Cost only includes Before School Care, Non-School Days and Breaks.</li> <li>Payments continue through the summer and include select summer camps</li> </ul>		\$540
<b>After School Care</b> <ul style="list-style-type: none"> <li>Cost only includes After School Care, Early Release days, Non-School Days and Breaks</li> <li>Payments continue through the summer and include select summer camps</li> </ul>		\$550

**Occasional Care**

Occasional Care is a service we provide to families whose children are enrolled in the YMCA School Age Care program. It is care on an irregular basis outside of the regular enrollment. Occasional Care is not available at all sites and times. Payment must be made in advance. Participants must receive prior approval from program staff to confirm space is available.

## DEFINITION OF TERMS

<b>Registration Fee:</b>	All registrations require a \$50 non-refundable registration fee per child, per school year.
<b>Program Shutdown:</b>	Programs may shut down for 1-3 days at the end of the school year and/or the end of summer for site preparation and staff training. Notice will be provided of the specific dates at least 6 weeks prior to the closures. Subject to change if the school calendar changes
<b>Withdrawals &amp; Vacation:</b>	A fifteen-day written notice is required for all withdrawals, vacation requests or changes in care to be eligible for credit or refund if eligible. Please request a Child Care Change Form to provide this notice.
<b>Non-School and Break Days:</b>	Additional "mini" registrations are required for non-school days and school breaks for all participants. Registration for all non-school and break days close the Wednesday prior to care.
<b>Holidays:</b>	Care is available on Martin Luther King Jr. Day. Care may be provided at an alternate site pending enrollment numbers. Care is NOT available on New Year's Day, President's Day, Memorial Day, 4th of July, Labor Day, Veteran's Day, Thanksgiving, the day after Thanksgiving, Christmas Eve and Christmas Day. Programs may close early on New Year's Eve.
<b>Occasional Care:</b>	<b>Occasional Care is a service we provide to families whose children are enrolled in the YMCA School Age Care program. It is care on an irregular basis outside of the regular enrollment.</b> Occasional Care is not available at all sites and times. Payment must be made in advance. Participants must receive prior approval from program staff to confirm space is available.
<b>Membership</b>	A Youth Facility Membership is included with enrollment in one of the School-Age Care plans (School Days, School Year, or Year Round) for the duration of the current year's enrollment. If you have a family membership you will receive a discount of \$20 per month off your membership fee. Families who withdraw from enrollment will have the option to continue their facility membership at the regular price.

**Multiple Children Discount:** Families with more than one child will be given a 10% discount on the lesser rate.

## PAYMENT METHOD OPTIONS

<b>Credit Card or Bank Draft:</b>	Automatic draft is the preferred payment method. Families have two draft options: <ol style="list-style-type: none"><li>1. To pay in full on the 25<sup>th</sup> of each month prior to care</li><li>2. Split their payments in two, with half drafting on the 10<sup>th</sup> of the month prior to care and the other half on the 25<sup>th</sup> of the month prior to care.</li></ol> If you are registering with less than 15 days before your first draft, payment is due in full upon registration.
<b>Standard Pay:</b>	Child Care payments paid by check or cash are due by the 25 <sup>th</sup> of the month prior to the month of care. If payment is not received, your child will not be eligible to attend on the 1 <sup>st</sup> day of the month. A \$30 late fee will be applied to all late payments.
<b>DSHS and Government Subsidy:</b>	The YMCA accepts DSHS subsidies. Co-pays are due by the 25 <sup>th</sup> of month prior to care. DSHS provider numbers are available at the Branch. Co-pays are subject to the same payment deadlines for care. Children who qualify for DSHS subsidy will receive a Free 1-year Facility Membership.
<b>Financial Aid:</b>	Financial aid is available to those who qualify. Assistance is granted on a first come first serve basis. Assistance will be granted for a maximum of the length of the program. You can reapply to receive continued assistance.
